City of Karratha Conditions relating to the sale of property from Reserve 45496 Bathgate Road known as Dreamers Hill:

- 1) No trucks, commercial/mine vehicles (i.e. earthmoving machinery etc.) will be permitted to be sold from the site. Vehicle sales are to be limited to private vehicles, boats, car trailers, caravans and motorcycles only.
- 2) Only one **permit per vehicle type per year** will be issued to any person, to prevent any person operating as an unlicensed car dealer.
- 3) The issued permit is valid on Saturdays, Sundays and Gazetted Public Holidays only. All vehicles must be off site by 8.00am the following working day. Failure to remove item for sale will result in enforcement action being taken.
- 4) Trading permit will expire 4 weekends after payment has been made. If that vehicle has not sold, another permit may be applied for the same vehicle.
- 5) Vehicle is to be displayed within the confines of Dreamers Hill. No vehicles are permitted to be displayed outside the boundary of the site. Those vehicles which are displayed for sale outside of the boundary of the site will be subject to enforcement action/seizure.
- 6) Vehicles are to be parked perpendicular to the reserve boundary to allow space for all users of the site. The middle island is to be used by cars and 4x4s only as per the plan of site. Refer to plan diagram.
- 7) The City of Karratha takes no responsibility or liability for any vehicle displayed for sale on Dreamers Hill. Display and sale of the vehicle is done so at the risk of the vendor.
- 8) Permit to display for trade is to be fixed to the advertising papers on the vehicle at all times when it is displayed for trade at Dreamers Hill.
